GET A MARYLAND STATE TAX CREDIT FOR YOUR CONTRIBUTION TO RASH FIELD PARK

YOUR CONTRIBUTION OF \$1,000 OR MORE TO WATERFRONT PARTNERSHIP MAY QUALIFY FOR A 50% TAX CREDIT ON YOUR 2019 TAX RETURN IN ADDITION TO A CHARITABLE DEDUCTION ON YOUR FEDERAL AND STATE TAXES.

HERE'S HOW IT WORKS

Waterfront Partnership is raising \$50,000 to fully leverage state tax credits we were awarded to support the redesign of Rash Field Park into an active and attractive park space. You can take advantage of these tax credits if you are:

- An individual or fiduciary having personal tax liability in the State of Maryland.
- An entity that conducts a trade or business in the State of Maryland and are subject to the State income tax on individuals or corporations, the public service company franchise tax, or the insurance premium tax.
- New donors making their first contribution to Rash Field Park in 2018.
- Donors increasing their contribution to Rash Field Park in 2018.

Community Investment Tax Credits are available for eligible donors to make new or increase contributions of \$1,000 or more to Rash Field Park. These tax credits reduce the cost of a charitable contribution and reward donors who give back to their local communities.

EXAMPLE: HOW THE COMMUNITY TAX CREDIT WORKS IF YOU DONATE \$1000*

\$1,000	You contribute \$1,000 to Rash Field Park
\$500	A \$500 non-refundable Community Investment Tax Credit reduces your Maryland state tax liability
\$250	Your federal taxes are reduced by \$250 (based on a 25% federal tax rate)
\$250	The net cost of your \$1,000 contribution to Rash Field Park is \$250

- + To host regional special events including charity walks, cause related runs, Light City Baltimore, and Baltimore Book Festival as well as smaller events like family reunions.
